MCABC's Board of Directors has approved a donation to the Red Cross Hurricane Fiona In Canada Appeal, adding to the significant contribution made by the mechanical contracting industry across Canada. Every donation made through the Red Cross Appeal will be matched by the federal government until October 25.

This week is a big one for industry employers hiring apprentices in BC. As the largest skilled trades group, mechanical contractors have an opportunity to tap into significant federal funding to BCCA to support apprenticeship and diversity. Employers are eligible to receive payments for up to two first-year apprenticeship positions per year over a two-year period, to a maximum of \$40,000 per employer. MCABC encourages members to apply today.

- \$5,000 for hiring or registering any new first-year apprentice
- An additional \$5,000 if the worker:
 - self-reports as a woman, new Canadian, LGBTQ2S+
 - Indigenous
 - A person with a disability
 - A visible minority

Get Funding for Adopting New Digital Tools

The Government of Canada, through its Canada Digital Adoption Program (CDAP), is offering eligible businesses a loan of up to \$100,000 at 0% interest for a 6-year term. The CDAP is geared to help businesses have an ecommerce presence and digitize business operations.

Businesses must have at least \$500,000 of sales in any of 2018, 2019, 2020 or 2021; have at least one full time employee in the business; and use an approved digital advisor to create a digital adoption plan. Learn more.

Gas Safety Regulation Amendments and Adopted Code Revisions

A number of new gas codes, including the 2020 edition of the CSA B149 gas code series, have now been adopted into regulation and are in effect in BC as of October 1, 2022. View the <u>summary of changes and the consultation report</u>.
